# Georgia Institute of Technology Graduate Curriculum Committee <u>Minutes</u> November 5, 2009

1. A motion was made to table a request from the School of Biology for a new course. The motion was seconded and approved.

**New Course: TABLED** 

BIOL 7015: Cancer Biology and Technology 3-0-3

Committee recommended that the Expected Mode of Presentation percentages on NCP be changed to Lecture 60%, Discussion 20%, Seminar 10%, Independent Study 10%.

It was unclear about the difference between the undergraduate and graduate versions of this course. The course appeared to be very rigorous and delivered at a high level with high expectations of the student as far as assignments. For courses that have both undergraduate and graduate students enrolled in them, there is an expectation of more or different assignments for the graduate students. For example, in this case would the graduate students serve as the group leaders and be the ones making presentations on behalf of the groups?

2. A motion was made to approve a request from the School of International Affairs for new courses, deactivation of courses, and modification of degrees. The motion was seconded and approved.

# **Modification of Degree:**

Master of Science in International Affairs

- 1. Create four tracks for this degree of which students will choose to complete two of the four:
  - a. International Affairs and Security
  - b. Globalization and Development
  - c. Comparative and Regional Studies
  - d. Science and Technology
- 2. Redesign INTA 6003 Empirical Research Methods to provide more focus on statistical methods. By redesigning INTA 6003 (and deleting INTA 6004) the aim was to reduce the number of core courses to allow greater program flexibility. At the same time, there is a move to introduce coherent Track Electives to provide more in-depth knowledge, while allowing choice among subfields. Since a degree in "international" affairs is being issued, the foreign language requirement needs to be more rigorous. And, given that many of the students are attractive job candidates because of their technological skills, it was desirable to assure proficiency in this area by asking the students to fulfill this requirement in-house.

#### **Modification of Degree:**

Introduce coherent track electives to provide deeper knowledge base while adding flexibility among subfields of the program. Some key highlights of the proposed modification:

- Move from 9 core (27 hours) courses to 7 core (19 hours)
- Establish Major Tracks of which students must choose two to complete:
  - Student-created (Unique Track): Graduate Program Director- and Facultyapproved Track
  - o International Affairs and Security
  - o Globalization and Development
  - o Comparative and Regional Studies

- Adding oral defense to the required Science and Technology paper
- Foreign language/Advanced Methods requirement enhanced so students must demonstrate oral (speaking) proficiency in addition to reading ability
  - All students must take two years of a foreign language and complete INTA 6003(Empirical Research Methods) to demonstrate a more advanced proficiency.
  - o Then students must decide to
    - 1) complete a third year of a foreign language while attaining a "B" average or passing the proficiency exam, or,
    - 2) complete two methods courses beyond INTA 6003 while attaining a "B" average to demonstrate advanced methods proficiency.
- Reduction of INTA 7010 credit hours (Proseminar) from three to one as course is less rigorous

3. A motion was made to approve a request from the College of Management for a blanket granting of exceptions to the limit of pass/fail hours that can be used to graduate. The motion was seconded and approved.

Note: The exceptions were granted for the current cohort of students. The Committee has asked the College of Management to present a formal request that will address the regulation within the curriculum for any future cohorts of students. The Committee requests that the College of Management report back to them its plan for corrective actions at the January IGCC meeting.

4. The Committee discussed the procedures for reviewing applicants who do not hold Bachelor's degree. It was determined that schools or departments with questions about this should refer to the guidelines on the ICC web site. Specific questions about specific applicants will be routed through Graduate Admissions.
