

Minutes of the Undergraduate Curriculum Committee

October 11, 2000

1. Joe Hughes stated that the IUCC was responsible for reviewing each undergraduate degree program every five years, along with a complete program review as required by the Board of Regents. Hughes will work with Joseph Hoey to develop a letter to be sent to the schools whose programs are to be evaluated this year.
2. A discussion was held concerning the GPAs for determining academic standing and inconsistencies that occur with these rules and the GPA requirements for graduation and honors. The committee felt that the inconsistencies were not appropriate and that the Student Rules and Regulations Committee should address this issue.

1-to have MATH grade changed to "I" (**denied**)

2-to waive 9-9-22 rule (**2 denied**)

- 2-to enroll more hours in addition to co-op course
- 1-to allow 3 semester hours for ap history
- 1-to be concurrently enrolled at Ga Tech and Ga Perimeter
- 1-to substitute MATH course for other MATH courses
- 1-to use ECON as social elective
