12. The SCHOOL OF MECHANICAL ENGINEERING requested the following curriculum change to the BS NRE degree. A motion was made to approve the request. The motion was seconded and approved. Unanimous.

CURRICULUM CHANGE

Replace MATH 4581 with MATH/ISYE 3770.

13. The OFFICE OF INTERNATIONAL EDUCATION requested the approval of an International Plan degree designator for the bachelor's degree. This designator would be on the diploma and transcript and would be awarded based on the completion of designated courses in international affairs, global economics, modern languages and a capstone course in the major. The student must also complete two terms of residential foreign experience. The discussion centered on the lack of specific courses that would satisfy the requirements. There was also concern that there were no curricula from the major schools showing how a student from a particular major would satisfy the requirement. Approval would also allow for a blanket waiver of the 36 hour rule. A motion was made to approve the request. The motion was seconded and approved. Vote 8 for, 3 against.

Note: on 5 November, the IUCC voted to revisit item 13 to solicit input from faculty on the international plan. Vote 12 to revisit, 2 against.
