- 7. The sub-committee considering the courses for undergraduate TA's gave a report. The report suggested that courses be created to reflect TA activity and also a course should be created for training TA's. After much discussion Chair Wills said that he would summarize the discussion and send it out to the Committee for consideration and approval.
- 8. Chair Wills requested a discussion of a degree designator which included our current designators and what the Committee felt should be required of a program to receive a degree designator. The consensus of the Committee was that a definition should be established to give some structure to the requests and discussion of any new designators in the future.
- 9. Amy Bruckman presented for discussion the "Research Plan" Degree Designation for undergraduate degrees. There was much discussion including how departments currently handle undergraduate research, the thesis writing course and requirements for research activity.
